

**TOWNSHIP OF PEQUANNOCK**

**ORDINANCE NO. 2011-22**

**AN ORDINANCE AMENDING AN ORDINANCE ENTITLED AN ORDINANCE PROVIDING FOR A PAY PLAN, FRINGE BENEFITS AND PROVIDING FOR PERSONNEL RULES AND REGULATIONS FOR EMPLOYEES IN THE TOWNSHIP OF PEQUANNOCK.**

**NOW, THEREFORE, BE IT ORDAINED** BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF PEQUANNOCK IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY AS FOLLOWS:

SECTION I. This ordinance shall amend the minimum and maximum salaries and pay rates for selected positions in the Township which are not covered by a collective bargaining agreement. The salaries indicated within the range are those that will be in effect retroactive to January 1, 2011 upon final passage of this ordinance in accordance with and subject to the provisions of Chapter 29 of the Township Code.


SECTION III. Any Ordinance inconsistent herewith is hereby repealed.


