

**TOWNSHIP OF PEQUANNOCK**

**ORDINANCE NO. 2014-16**

**AN ORDINANCE AUTHORIZING VARIOUS CAPITAL IMPROVEMENTS AND APPROPRIATING \$1,137,000.00 FROM EXISTING CAPITAL FUND BALANCES AND RESERVES.**

**BE IT ORDAINED** by the Township Council of the Township of Pequannock, in the County of Morris and State of New Jersey as follows:

**SECTION 1.** The sum of \$1,137,000.00 is hereby appropriated from the following designated Capital Fund Balances and Capital Reserves:



**SECTION 3.** The Capital Budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies herewith.

**SECTION 4.** This Ordinance shall take effect after final passage and publication in the manner provided by law.
