

**TOWNSHIP OF PEQUANNOCK**

**ORDINANCE NO. 2016-09**

**AN ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE TOWNSHIP OF PEQUANNOCK, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY AND APPROPRIATING THE SUM OF \$613,000 FOR FINANCING THEREOF**

**BE IT ORDAINED** by the Township Council of the Township of Pequannock, County of Morris, as follows:

**SECTION 1.** \$66,000.00 is hereby appropriated from the General Capital Fund Balance; \$115,000.00 is hereby appropriated from the General Capital Reserve for Vehicle Replacement; \$120,000.00 is hereby appropriated from the General Capital Reserve for DPW Equipment; \$300,000.00 is hereby appropriated from the General Capital Reserve for Road Resurfacing; \$12,000.00 is hereby appropriated from the General Capital Reserve for Data & Office Equipment, thereby in aggregate appropriating \$613,000 for the following improvements in and by the Township of Pequannock, in the County of Morris, New Jersey:

<b>PURPOSE</b>	<b>Amount Appropriated</b>
(a) Replace Approximately 15 PC Systems that are 4 years old or older for various municipal offices; and replacement of PC's for the Library.	\$ 16,500
(b) Repairs and renovations to municipal buildings including Town Hall, the DPW Annex and Building Improvements at Fire Co #2.	\$ 27,500
(c) Drainage system repairs along Shady Brook and Shady Brook Park area design and development; Drainage improvements at various locations throughout the Township including materials necessary for same.	\$ 15,500
(d) Resurfacing of various roads in the Township to include milling and paving and various curb and drainage repairs as necessary.	\$ 301,000
(e) Purchase and installation of park equipment including replacement signage, grills and picnic tables for municipal parks.	\$ 7,250
(f) Purchase of replacement vehicles and equipment including 1) replacement of an Ambulance for the First Aid Squad; 2) replacement of DPW Pick-up truck 66; 3) Replacement of a Loader / Backhoe; and 4) an administrative vehicle for the Health Department.	\$ 234,000

(g) Purchase and installation of equipment at the Township Vehicle shop including a pressure washer.	\$ 11,250
TOTAL	\$ 613,000

**SECTION 2.** The improvements hereby authorized and the purposes for which this appropriation is made includes all costs and materials necessary therefor and incidental thereto. An amount not exceeding \$9,000 for items of expense listed in and permitted under NJSA 40A:2-20 is included in the costs indicated herein for the improvement.


**SECTION 3.** The Capital Budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies herewith.
