PUBLIC COMMENT.

- Alberta Alleva, 75 West Parkway, requested the Council consider a shared-service arrangement with Lincoln Park for recreation programs; and suggested the Township provide Green Mountain bus trips. Mayor Phelan suggested bringing the request to the Parks and Recreation advisory committee.
- Henry Samek, 4 Misty Court, stated that he did not understand violation letters sent by the Township concerning snow plows and trailers parked in driveways.
- Pete Balasis, 19 Greenview Drive, objected to a letter he received concerning equipment in his driveway
- Rocco Salluce, 153 Jacksonville, requested status on the lot next to the gas station on the Turnpike.
- Tom Molica, 12 Saddle Drive, requested status on the TV cameras and suggested inserting an additional showing of the Board of Education meeting.
- Matt Colombo, 86 Mountain Avenue, suggested the Township consider instituting "pay-as-you-throw" trash collection fees when the existing contract expires.
- Rocco Salluce, 153 Jacksonville, reminded the Council the Township previously let each property owner negotiate individual agreements for trash collection, and commented on the status of the cameras.

MANAGER'S REPORT. Township Manager David Hollberg reported the following:

- Work by Morris County to remove the rails from the railroad crossing at Newark Pompton Turnpike has been completed.
- Work on the Boulevard paving project by Morris County will begin next week with curb and ramp replacement followed by milling and paving from Lincoln Park Road to Cooper Road.
- Bids for the West Franklin Improvement project will be opened this Thursday, anticipating a bid award on September 10th.
- Bids for river desnagging and debris clearing along the Pequannock and Pompton rivers will be advertised this week and bids will be opened on September 19. After legislative action, NJDEP has announced additional funds will be made available through the grant process for desnagging projects in the Passaic River basin. Pequannock Township will apply for additional funding once the grant applications are available and we will begin the process of obtaining permits to work in other sections of the river.
- All documentation has been submitted to NJOEM for over \$1.1 Million in reimbursements for acquisitions made under the Severe Repetitive Loss (SRL) Grant program. An additional 5 properties are scheduled for closing in the coming weeks.
- A dedication ceremony for the Water Blending Facility will be held on Saturday, September 14 at 10:00 a.m.
- The Township has received a \$20,000 grant from the New Jersey Forestry Service to support our Community Forestry Plan. The Shade Tree Commission will develop the specific plan for the use of these funds.
- Pequannock Township will "go pink" in October for Breast Cancer Awareness month. Township employees will show their support by wearing pink on Friday, October 18.
- Our Township Fireworks will be this Sunday, September 1 at 8:00pm at the High School Field.

Township Manager Hollberg:

- Requested an update on Council iPads.
- Reported that Flood Insurance rates are increasing to actuary rates over the next few years and immediately for new owners. The Council will encourage people to elevate their homes.
- NJ Monthly rated Pequannock #14 of 100 in the State.
- Noted the 2-year anniversary of hurricane Irene.
- Announced an MIA/POW Remembrance on September 20 at 4:00 p.m. in front of Town Hall.

PUBLIC COMMENT.

■ Ken Hardaker, 8 Brookside Avenue, requested information concerning the cost of delaying the Village Área Sewer project, including cost of the project and the cost to homeowners.

- Rocco Salluce, 153 Jacksonville Road, requested information on the paving of the railroad tracks and the cost of the generators approved for purchase in Resolution R2013-131; questioned if the Pequannock Newsletter is an official publication.
- Henry Samek, 4 Misty Court, noted that an increase in generators affects gas supplies; and suggested setting aside \$500,000 in surplus for 10 years to finance a community pool.
- Jeff Mauriello, 13 Wren Place, announced he is working on a petition requesting a dead end where Van Dyk meets West Parkway. The petition has the support of 100% of Wren residents and 76% of Van Dyk residents.
- Lou Hebert, 11 Copley Court, questioned if there will be a September 11 Service.

EXECUTIVE (CLOSED) SESSION. On a motion by Mr. Vanderhoff, seconded by Mrs. Florance-Lynch, the council unanimously approved **Resolution R2013-134**, authorizing an Executive Session to discuss potential litigation related to the Lucas Bid withdrawal request, property acquisition, and a sewer appeal.

The public portion of the meeting was recessed at 8:15 p.m. followed by the Executive Session at 8:20 p.m. during which the following items were discussed:

- Litigation Lucas Construction. Project engineer Michael Simone joined the closed session for this discussion. Township Attorney Oostdyk and Township Manager reported on the litigation and the Township's position and strategy under various scenarios.
- Property Acquisition Jefferson Street. Township Manager Hollberg reported on the status of negotiations; Council members expressed their support for acquisition which is generally dependent on the purchase price and funding source. Mr. Hollberg was authorized to continue discussions with the owner and explore funding options.
- Litigation sewer appeal. Township Attorney Oostdyk reported on the status of sewer assessment issues and was provided authorization to seek settlement of outstanding issues.

The closed session concluded at 8:47 p.m. at which time the Council reconvened the public meeting and Township Attorney Oostdyk summarized the Executive Session discussion. No formal action was taken.

APPROVAL OF MINUTES. There were no minutes presented for approval.

ADJOURNMENT. There being no further business the meeting was adjourned at 8:48 p.m. without objection.
