Retail Food Complaints

Florham Park: Hunan Wok—This establishment was closed due to severe sanitation deficiencies. The ceiling of the walk in refrigerator was leaking profusely. All food was discarded due to possible contamination. The establishment was re-inspected throughout the week until all violations were abated. Repairs were done to the walk in box and the refrigeration units in the box were professionally cleaned. The establishment reopened with a Conditionally Satisfactory. Two weeks after this rating was given, another inspection was done which was Satisfactory. The owner and employees were given food handling course dates to attend in Bergen County.

Riverdale: Riverdale Square—A follow up inspection was done to verify that the garbage area behind the complex has been cleaned and maintained. The Chinese Buffet now has a segregated area which is contained and fenced. The only violation that was evident was one cover missing on one of the dumpsters. The property manager was notified to correct the issue.
