ORDINANCE NO. 2021-08

ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE TOWNSHIP OF PEQUANNOCK, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY AND APPROPRIATING THE SUM OF \$1,605,207 FOR FINANCING THEREOF

BE IT ORDAINED by the Township Council of the Township of Pequannock, County of Morris, as follows:

SECTION 1. \$450,000 is hereby appropriated from the General Capital Reserve for Road Resurfacing; \$847,883 from the Capital Improvement Fund; \$25,000 is hereby appropriated from Reserve for Flood Improvements; \$35,000 is hereby appropriated from the Reserve for Office Equipment; \$58,500 is hereby appropriated from the Reserve for DPE Equipment; and \$188,824 is hereby appropriated from the Reserve for Vehicle Replacements thereby in aggregate appropriating **\$ 1,605,207** for the following improvements in and by the Township of Pequannock, in the County of Morris, New Jersey:

(e) Building Improvements, Acquisitions, and Upgrades to Municipal Facilities Including but not Limited to: Co#2 Radio Room, Co#1 Roof Replacement, DPW Metal Structure, Townhall Building Improvements, Library Roof, & Senior House Generator	\$ 242,100
(f) Police, Dispatch, & Law Enforcement Equipment Including, but not Limited to: Lawsoft Records Management Software, Patrol Rifle Program, Replacement of Dispatch Equipment, and NIBRIS Software	\$ 169,607
(g) Park & Recreational Improvements Including, but not Limited to: Shade Tree Replacements, PV Park Basketball Court, PV Park Umbrellas, & PV Park Raft	\$ 60,500
(h) Public Works Equipment Purchases and Upgrades Including, but not Limited to: Paint Machine, Upgrade Fuel System Pedestal, and Vehicle AC Machine	\$ 48,500
TOTAL	\$ 1,605,207

SECTION 2. The Capital Budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies herewith.

SECTION 3. This ordinance shall take effect 20 days after final adoption, as provided by law.
