#### ORDINANCE NO. 2023-03

AN ORDINANCE AMENDING CHAPTER 5 OF THE CODE OF THE TOWNSHIP OF PEQUANNOCK AND DISSOLVING THE FAIR HOUSING AND TEEN ADVISORY COMMITTEES

WHEREAS, the Township established a Fair Housing and Teen Advisory Committees by ordinance; and

WHEREAS, the Township Council recognizes and appreciates the efforts of those who served on these Committees during the years they were in existence; and

WHEREAS, the Township Council has determined that it is now prudent to dissolve these Committees and allow other advisory committees or Township Administration to address the issues previously handled by these Committees.

NOW, THEREFORE, BE IT ORDAINED, by the Township Council of the Township of Pequannock, in the County of Morris and State of New Jersey, as follows:

Section 1. Chapter 5, Section 5-41 of the Revised General Ordinances of the Township of Pequannock, entitled "Fair Housing Committee", shall be repealed in its entirety.

Section 2. Chapter 5, Section 5-43 of the Revised General Ordinances of the Township of Pequannock, entitled "Teen Advisory Committee", shall be repealed in its entirety.

Section 3. If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 4. All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 5. This Ordinance shall take effect immediately after final passage and publication in the manner provided by law (\$43.68)
