ORDINANCE NO. 2017-09

AN ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE TOWNSHIP OF PEQUANNOCK, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY AND APPROPRIATING THE SUM OF \$1,070,000 FOR FINANCING THEREOF

BE IT ORDAINED by the Township Council of the Township of Pequannock, County of Morris, as follows:

SECTION 1. \$86,500.00 is hereby appropriated from the General Capital Fund Balance; \$30,000.00 is hereby appropriated from the General Capital Reserve for Vehicle Replacement; \$60,500.00 is hereby appropriated from the General Capital Reserve for DPW Equipment; \$210,000.00 is hereby appropriated from the General Capital Reserve for Road Resurfacing; \$33,000.00 is hereby appropriated from the General Capital Reserve for Data & Office Equipment; \$650,000.00 is hereby appropriated from the General Capital Reserve for Fire Apparatus, thereby in aggregate appropriating \$1,070,000 for the following improvements in and by the Township of Pequannock, in the County of Morris, New Jersey:

Purpose	Amount Appropriated
(a) Replace Approximately 15 PC Systems that are 4 years old or older for various municipal offices; purchase of a replacement High Volume Digital Network Copier; and replacement of PC's for the Library.	\$ 33,000
(b) Repairs and renovations to municipal buildings including Town Hall, the Henning House Fire Safety Annex and Animal Shelter, including furnishings.	\$ 49,000
(c) Purchase of Fire Apparatus to replace Engine 2-2, including associated equipment and appurtenances associated with same.	\$ 651,000
(d) Acquisition of a power stretcher for the Pequannock Township First Aid Squad.	\$ 21,000
(e) Roadway, Sidewalk and Drainage improvements along Mountain Avenue at various locations including, but not limited to, the section from West Parkway to the Boulevard to improve drainage and pedestrian safety; Drainage improvements at various location though out the Township.	\$ 226,000
(f) Purchase of DPW and Parks equipment including Infield protraction equipment, mowers for field and ground maintenance, and a skid mount salt brine spreader.	\$ 60,000
(g) Purchase of a replacement administrative vehicle for the Health Department.	\$ 30,000
TOTAL	\$1,070,000

SECTION 2. The improvements hereby authorized and the purposes for which this appropriation is made includes all costs and materials necessary therefor and incidental

thereto. An amount not exceeding \$4,900 for items of expense listed in and permitted under NJSA 40A:2-20 is included in the costs indicated herein for the improvement.

SECTION 3. The Capital Budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies herewith.

SECTION 4. This Ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by law.
