## **ORDINANCE NO. 2018-10**

ORDINANCE APPROPRIATING \$1,042,000 FROM THE CAPITAL IMPROVEMENT FUND FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE TOWNSHIP OF PEQUANNOCK, IN THE COUNTY OF MORRIS, NEW JERSEY

**BE IT ORDAINED** by the Township Council of the Township of Pequannock, County of Morris, as follows:

**SECTION 1**. \$1,042,000 is hereby appropriated from the Capital Improvement Fund for the following improvements in and by the Township of Pequannock, in the County of Morris, New Jersey:

(a) Acquisition and installation of equipment for the First Aid Squad	\$ 55,500
including a 2 Power Stretcher Loaders to be mounted in existing ambulances.	<del>!</del>
(b) Acquisition of Body Camera's for use in and by the Police	\$ 41,500
Department, including equipment, installation and training.	
(c) Construction of Sidewalks along Jacksonville Road to replace	\$ 171,000
deteriorated and heaved sections of Sidewalk; Construction of ADA	
Compliant Intersection Ramps, Replacement of unsafe sidewalk	
sections and Curb Improvements throughout the Township.	
(d) Roadway, Sidewalk and Drainage improvements along	\$ 176,000
Mountain Avenue at various locations including, but not limited to,	
the section from West Parkway to the Boulevard to improve	
drainage and pedestrian safety; Drainage improvements at various	
location though out the Township. Roadway Resurfacing at various	
locations throughout the Township	
(e) Repairs and renovations at the DPW Annex to include flooring	\$ 95,000
replacement, partial roof replacement and painting of interior	
areas.	
(f) Planning and Architectural Design for a new Municipal Building	\$ 351,000
to include space, site and location planning necessary to complete a	
final architectural design for a new building and minimize disruption	
of municipal services	
(d) Purchase and installation of park and safety equipment	\$ 152,000
including replacement benches, bleachers, fencing and backstops	
for use in various parks; Improvements to Washington Park	
including irrigation, parking improvements, sidewalks and park	
equipment; Improvements to Hillview Field.	
TOTAL	\$ 1,042,000

**SECTION 2**. The improvements hereby authorized and the purposes for which this appropriation is made includes all costs and materials necessary therefor and incidental thereto. An amount not exceeding \$355,500.00 for items of expense listed in and permitted under NJSA 40A:2-20 is included in the costs indicated herein for the improvement.

**SECTION 3**. The Capital Budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies herewith.

**SECTION 4**. This Ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by law.
