

TOWNSHIP OF PEQUANNOCK

ORDINANCE NO. 2018-12

ORDINANCE ESTABLISHING MINIMUM AND MAXIMUM SALARIES AND PAY RATES FOR DESIGNATED OFFICIALS AND EMPLOYEES OF THE TOWNSHIP OF PEQUANNOCK FOR THE YEAR 2018.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF PEQUANNOCK IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY AS FOLLOWS:

SECTION I. This ordinance shall amend the minimum and maximum salaries and pay rates for selected positions in the Township which are not covered by a collective bargaining agreement. The salaries indicated within the range are those that will be in effect retroactive to January 1, 2017 upon final passage of this ordinance in accordance with and subject to the provisions of Chapter 29 of the Township Code.

SECTION II. Schedules A, B, C, D, and E are hereby amended and established to read in their entirety as follows:


SECTION V. This Ordinance shall take effect after passage and publication as provided by Law.
