TOWNSHIP OF PEQUANNOCK ORDINANCE NO. 2019-07

ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE TOWNSHIP OF PEQUANNOCK, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY AND APPROPRIATING THE SUM OF \$1,203,000 FOR FINANCING THEREOF

BE IT ORDAINED by the Township Council of the Township of Pequannock, County of Morris, as follows:

SECTION 1. \$64,000 is hereby appropriated from the General Capital Reserve for DPW Equipment; \$304,800 is hereby appropriated from the General Capital Reserve for Road Resurfacing; \$15,500 is hereby appropriated from the General Capital Reserve for Data & Office Equipment, \$818,700 from the Capital Improvement Fund thereby in aggregate appropriating \$1,203,000 for the following improvements in and by the Township of Pequannock, in the County of Morris, New Jersey:
